## Peru

### REQUIREMENTS FOR U.S. CITIZENS TO OBTAIN VISA FOR PERU

#### TOURIST TRAVEL

- Visa **not required** for stay of up to 90 days.  
A valid U.S. Passport is required.

#### **TOURIST VISA REQUIRED:**

- None
- A valid passport is required to enter and depart Peru. Tourists must also provide evidence of return or onward travel. Travelers to Peru will receive a card from Peruvian Immigration upon arrival stating the length of approved stay (usually 90 days). Extensions are not available, and overstays will result in fines. Visit the [Embassy of Peru Website](#) for the most current visa information. Peru does not require any immunizations for entry, although it recommends vaccination against Yellow Fever.
- The U.S. Department of State is unaware of any HIV/AIDS entry restrictions for visitors to or foreign residents of Peru.

## Argentina

#### **TOURIST VISA REQUIRED:**

Not required for stays of 90 days or less

## **But .....**

A valid passport is required for U.S. citizens to enter Argentina. U.S. citizens do not need a visa for visits of up to 90 days for tourism or business. **Argentine law requires that, *prior to arrival in Argentina at***

any entry point, U.S. citizen tourist and business **travelers must pay a US\$160 reciprocity fee by credit card online at the [Provincia Pagos website](#)**. Once paid, you must print out the receipt and present it to the Argentine immigration officer at the time of entry. The fee is valid for ten years from the date of payment and multiple entries. **It is advisable to keep multiple copies of the receipt, as it must be presented every time you enter Argentina.** The fee applies only to bearers of tourist passports. Travelers bearing diplomatic or official passports are required to get visas prior to arrival in Argentina but are not charged the reciprocity fee, nor are travelers transiting and not entering Argentina.

## **Brazil**

### **TOURIST VISA REQUIRED:**

Not required **but .. similar to Argentina, a US\$160 reciprocity fee is required.**

## **Chile**

### **• TOURIST VISA REQUIRED:**

Not required for stays 90 days or less

U.S. citizens entering Chile must have a valid passport. U.S. citizens traveling to Chile for recreation, tourism, business, or academic conferences do not need to obtain a visa prior to their arrival in Chile. A Tourist Card will be issued for a stay of up to 90 days. An extension of stay for another 90 days is possible upon payment of an extension fee at the [Chilean Immigration Office](#) located at San Antonio 580, Santiago; telephone 56-2-2550-2469. The Tourist Card must be surrendered upon departure. Failure to submit this card upon departure may result in delays until a replacement is obtained. If lost or stolen, the Tourist Card must be replaced by the [International Police](#) (website is in Spanish only) at their nearest headquarters or at the international airport prior to departure.
